Each team will be assigned a 15' X 20' site with availability to electricity. Set-up starts no earlier than 7:00 am August 12, 2010. Each team will be supplied at least one Boston Butt to cook for competition. Contestants are responsible for bringing all equipment necessary for cooking. Gas, electric, charcoal or wood is permitted. All meat must be turned in no later than 5:00 pm on August 12, 2010. Each entry will be renumbered before it is served to the public so that the preparer remains anonymous. Judging will be by popular vote. Event staff will inspect all meat for doneness prior to it being served to the public.

Each cook site must be vacated before midnight August 12, 2010, unless a team has previously registered to compete in the KCBS Professional BBQ Contest or the Smokin' in McMinnville Backyard BBQ contest on August 14, 2010.
